- Parents/Guardians will place the emotional and physical well-being of the child ahead of a personal desire to win.

- Parents/Guardians will demand a sports environment for the child that is free of drugs, tobacco and alcohol and will refrain from their use at all games and practices.

RELEASE AND INDEMNIFICATION AGREEMENT



By signing below, I agree as follows:

- I represent and warrant that I am the lawful guardian of the following minor:
“Child” _____ (please print)
- I/Child acknowledge a desire for Child to participate in the Sturgis Recreation T-Ball Program that is operated by the City of Sturgis.
- I/Child acknowledge and fully understand that (A)baseball activities involve risks and dangers of serious bodily injury including, but not limited to, injury to the head, internal organs and brain, sprains, strains, broken bones, and PERMANENT DISABILITY, PARALYSIS AND DEATH (“Risks”); (B) these Risks and Dangers may be caused by child’s actions or inactions, the actions or inactions of others participating in the activity, the condition in which the activity takes place or the NEGLIGENCE of the released parties below; (C) there may be other Risks and social or economic losses either not known to me/child or not readily foreseeable at this time. I/Child fully accept and assume all such risks and the responsibility for losses, costs and damages incurred as a result of my child’s participation in the activity. I/Child further certify that Child is in good health and that Child has no physical limitations which would preclude safe participation. I/Child know Childs experience and capabilities and believe Child is qualified to participate in such activity. I/Child further acknowledge that I/Child am aware that the activity will be conducted in facilities or locations open to the public during the activity. I/Child further agree and warrant that if, at any time, I/Child believe conditions to be unsafe, Child will immediately discontinue further participation in the activity.
- As partial consideration for Child’s participation in T-Ball, I and Child release City of Sturgis, Doyle Community Center, Sturgis Recreation and its officers, members, employees, contractors, volunteers, agents, and their respective heirs and estates (the “Released Parties”) from any claims, rights, charges and/or causes of action (“Claims”) that my child or I may have now or in the future as a result of any injuries or damages he or she suffers (Including personal injury, property damage or death) as a result of participating in T-Ball.
- I and Child waive all claims (as defined above) and agree to not file or bring any suit or charge against the Released Parties with respect to the matters released.
- I will indemnify and hold harmless the Released Parties from any claims (as defined above) by third parties for injuries or damages arising from or in any way connected with Child’s participation in T-Ball. Said duty of indemnification shall include but not be limited to claims that the Released Parties acted negligently and shall include an obligation to reimburse the Released parties for any attorney fees or expenses they incur in connection with defense of the matters indemnified.
- **I/CHILD HAVE READ THIS RELEASE AND INDEMNIFICATION AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I/CHILD HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW** and agree that if any portion of this agreement is held to be invalid, that the balance, notwithstanding, shall continue in full force and effect.
